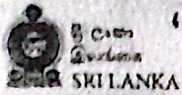

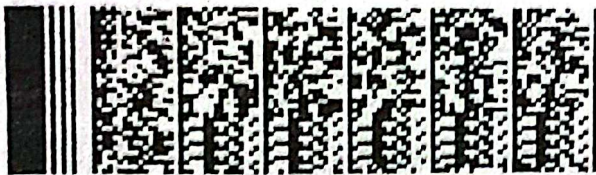

7. In the event of a pass book being lost or spoiled, the Bank on receiving satisfactory explanation from the account holder, may issue a fresh pass book. Account holder will be deemed have accepted the accuracy of entries contained in such passbooks.
8. Deciding the initial deposit to open a savings account, service charges, minimum average balance to be maintained, the rate of interest and method of computation and crediting of interest, will be in accordance with the prevailing rules and regulations of the Bank.
